Supply and Delivery of Bulk Propane - Amendment #6

Question and Answer

Question 1:

If a supplier other than the incumbent is awarded the SOA, would the new supplier be expected to pump out the propane from the existing incumbent-owned tank, remove that tank and set it aside, and then install their own tanks and put the propane back into the new tank?

Answer 1:

One of the vendors performs the transfer of propane (agreed by both vendors), OR
Current vendor provides credit for unused propane upon removal of the tank, OR
Current vendor provides transfer of the tank itself to a new vendor at cost or free of charge.

To be determined at time of contract award in consultation with incumbent and successful bidder.

Question 2:

Clarify which tanks are Crown owned and contractor owned. During the site visit, it was identified that serial PT-07, PT-08, PT-09 and PT-14 were owned by DRDC. However, DRDC staff provided different information. Please confirm which are Crown and which are contractor owned.
