The amendment 008 is raised to provide clarification to the document.

Question: The equipment table provided indicates UPS requirements for Viewing Station #1 (ref. line 183). Are the other three Viewing Stations not to be equipped with UPS power?

Response: No, only one viewing station needs UPS. The two others will only need surge protection.

Question: The meeting minutes identify the replacement of the CAT5 cable with fiber; how many strands, what style of fiber? Are there specifications for this requirement available?

Response: It will be up to the bidder to select the appropriate fibre with the capacity to service the needs of the system.

Question: Can a photo of existing cameras A1-28 or A1-31 be provided?

Response: Sorry but all vendors had the opportunity to take as many photos as they wished. Photos are not available.

Question: Is there a specification for the LPR camera identified to be supplied in the meeting minutes?

Question: Can the equipment tables or drawings be modified to identify new and existing cameras?

Response: Sorry but no drawings. (see with Infrastructure)

Question: Please describe the rating criteria that will be applied to select the successful proponent?

Response: All the specifications provided must be met or your submission will be eliminated as non-compliant. The lowest complaint bid will win the contract.

Question: Addendum 004 clarified that existing fiber can be reused; please provide existing fiber type and number of strands currently exists between the building and the poles and can it be re-used fibre, si est adequate peut?

Response: Existing fibre, if adequate, may, be re-used. Neither the lab nor the infrastructure group has information with respect to the quality of the exiting fibre.

Question: How long can the cameras be down while the new system is being installed?

Response: Ideally cameras should not be down for more than a week. Preferably, if cameras are down, not all of them will be down at the same time. For example, if they are working on cameras inside the building, those cameras may be down while the exterior cameras are functional and vice versa.

Question: Who will be responsible for exterior cabling, installation of new conduit and the restoration of landscaping or paved areas damaged during the installation of new conduits.

Response: The successful bidder will be fully responsible to do all necessary work including restoration of areas damaged because of the need to run new conduits or created by the installation of new posts.

Question: Who will be responsible to ensure that exterior cameras mounted to light standards will have the required 120 volts A.C. power?

Response: The electrical work required to provide the necessary power to the cameras will be the responsibility of the successful bidder.

Question: Who is responsible to provide new post for mounting cameras where no poles or posts currently exist?

Response: The successful bidder will be responsible to provide and install any additional infrastructure required to mount new cameras.

Will CBSA require new civil infrastructure (New poles, conduit, civil work, etc) to be installed to facilitate the installation of these cameras? If no new infrastructure is within scope, what is CBSA's direction regarding the exterior cameras location as noted in question #1?

Response: Yes additional work will be required to install aluminum poles where no poles presently exist. This will require concrete bases set below the frost line, as well as conduit for cabling and electrical. It also requires restoration of the landscape to its previous condition.
