This solicitation amendment No. 006 is raised to:

- 1) publish questions and answers that have been received in relation to this solicitation.

- 1) The following Question and Answer has been provided:

QUESTION 1:

"Given that this RFP requires experience with niche technologies such as MATLAB, we would like to ask that the crown conduct reference checks in situations where experience is claimed in niche technology areas. Can the crown confirm that references are a necessary and essential part of TBIPS-Professional Services Support (W7719-175346/B)? Our belief is that it is in the best interest of the crown to ensure that resume falsification is both avoided and discouraged; reference checks are an essential manner in which the crown guarantees a transparent, fair, and competitive procurement process."

ANSWER 1:

References are a necessary and essential part of solicitation W7719-175346/B. Provisions for calling upon references have been provided under the TBIPS RFP, Part 3.2 (b)(v) of solicitation W7719-175346/B; "The Bidder must provide customer references who must each confirm, if requested by Canada, the facts identified in the Bidder's bid, as required by Attachment 4.1 – Bid Evaluation Criteria." Canada reserves the right to request references.
