Addendum No. 11

1. SPECIFICATION

SECTION 01 10 10 GENERAL INSTRUCTIONS

Page 3, within subsection 1.5 add: "11. Contractor must negotiate a lease agreement with the Harbour Authority for the use of the laydown area and areas of the wharf which will be occupied during construction".

SECTION 35 70 00 MISCELLANEOUS ITEMS

Page 2 within subsection 2.1 paragraph 4, delete:

"Hot dip galvanize bolts, anchor bolts, nuts, washers, pip sleeves, steel plates, rungs, holdfasts, U-bolts and any other miscellaneous steel to ASTM A123/A123M with minimum zinc coating of 600 g/m². All sharp corners, edges and weld splatter to be ground smooth prior to galvanizing."

And replace with:

"Hot dip galvanize bolts, anchor bolts, nuts, washers, pipe sleeves, steel plates (excluding SSP protection plates), rungs, holdfasts, U-bolts and any other miscellaneous steel to ASTM A123/A123M with minimum zinc coating of 600 g/m². All sharp corners, edges and weld splatter to be ground smooth prior to galvanizing."
