Question 1:

Re: Solicitation closing date. Given the short turnaround time of this solicitation as well as the high level of volume and complexity required to prepare a response, would the Crown please extend the solicitation closing date by two weeks to July 20, 2017?

Answer 1:

Agreed. See amendment below.

Question 2:

Re: Appendix B of Attachment 4.1 - Resource Project Template. Can the Crown please clarify the usage of this form in solicitation responses? Section 3.2 Section I: Technical Bid, (v) For Proposed Resources states that "The Technical bid must include resumes for the resources as identified in Attachment "4.1". Can the Crown confirm that providing the information requested by the Resource Project Template within candidate resumes will be sufficient in demonstrating the mandatory and point rated criteria?

Answer 2:

Bidders are required to use the Project Templates provided in Appendix B of Attachment 4.1 to demonstrate Resources' experience. Résumés are not required for proposed resources. See amendment below.

Question 3:

Re: Appendix B of Attachment 4.1 - Resource Project Template. The sixth row of the Resource Project Template requests the Name, Title, and Contact Information for each resource project claimed against the Mandatory and Point Rated Criteria. For Level 3 resources (which require a minimum of 10 years of experience), it is unreasonable to request contact information for projects 10 years (or further) in the past. Please confirm that client contact information will only be required for projects undertaken within the past 5 years.

Answer 3:

Agreed. The requirement to provide Contact information for projects that are 10 years old is amended to require Contact information for projects completed within the past five years prior to solicitation issue date. However, detailed project descriptions of older projects that make out the required minimum 10 years' experience for level 3 resources, including identification of the Client, remain a requirement for demonstration of experience within the last ten years. Question 5:

Re: Annex A, Statement of Work: Given the detailed requirements contained in Annex A for Transition In and Contract Initiation Meeting (both tied to Contract Award), can the Crown please provide Bidders with the target date for Contract Award? This will be extremely beneficial to Bidders in preparing presentations and ensuring that key Bidder resources will be available.

Expected Contract Award date is mid-September, 2017.

Question 6:

With reference to R8 – A.6 Programmer/Software Developer – Level 2:

Criterion 3 in the Point-Rated grid has 4 bullet points; however, the scoring has five elements. Elsewhere in the RFP, the scoring relates directly to the associated criterion and we assume it should be here as well. Could the Crown confirm whether the criteria or the scoring is correct and provide an updated Point-Rated grid for R8?

Answer 6:

That is correct. It appears that one of the factors in the left hand column has been mistakenly deleted from the Level 2 Programmer/Software Developer. The criterion consists of five elements. See amendment below.

Question 7:

With respect to Point-Rated criteria, page 72 specifies that each project must have a minimum duration of twelve (12) months. However, the Bidder Project Template on page 96 states that Projects must be a minimum duration of six (6) months. Could the Crown please confirm the minimum project duration?

Answer 7:

The Point-Rated criteria on page 72 is correct. There has been an error on the Bidder Project Template on page 96. The project must have a minimum duration of twelve months. See amendment below.
