To ensure consistency and quality of information provided to bidders, significant enquiries received and the replies to such enquiries will be provided simultaneously to bidders to which the bid solicitation has been sent, without revealing the sources of the enquiries.

Here is one question which we have received until now:

Question 1: Ref: Annex A, section A.14, Characteristics No 6 and 10 - Sweeper Width

What is the difference between characteristics No 6 and 10 regarding the sweeper width?

Answer 1: The characteristic no 6 is deleted and no 10 changed as follows:

Delete:

6	Sweeper width 366 cm (144") or less

Delete:

10	Overall width 460 cm (181") or less

Insert:

10	The overall width of the runway sweeper must not exceed 14 feet (168 inches) to access within a garage.
----	---

As indicated in characteristic No 16, the foot broom must between 166 and 168 inches length, but its overall length, broom with its attachments, could be longer, as long as, once broom tilted (working angle), the overall width of runway sweeper does not exceed 14 feet (168 inches) as required in the characteristic No. 10.

All other terms and conditions of the solicitation remain the same.
