AMENDMENT 005

This amendment is being raised to revise the bid price form and to respond to questions submitted in response to solicitation 5P420-17-5149/A:

A. QUESTIONS AND ANSWERS

- Q3. Is there currently means to offload barge with supplies and materials at site?
- A3. Yes there is a doc and stairway which needs to be removed as part of the project.
- Q4. What is the width of the boardwalk for navigating purposes, and if we should need to move off of the ramp can we set up blocking and plywood pads?
- A4. Between Staff House and Depot 4 foot. Work should be planned to not leave the boardwalk, but if required your idea of blocking and plywood would suffice
- Q5. Is there any equipment on site for this project at all?
- A5. No
- Q6. Is there a store there or do we bring in all food with us?
- A6. All food must be taken in, no store anywhere nearby. Gillam is the departure point for those headed in to York Factory. You will need to do additional food shipments throughout the summer as there is not storage for that much at once.
- Q7. Are the sand bags being supplied on site or do we haul those to site?
- A7. There is material near the site. Empty bags must be supplied by the contractor.
- Q8. Only one dock supplier has commented that he can meet specification (Candock systems)
- A8. That is acceptable.
- Q9. Finishing and painting specifications for all windows or just repaired ones?
- A9. See DSP 2 17-5149 folder for further information.
- Q10. Lodging and kitchen is provided for subs, correct at no charge?
- A10. Correct, the contractor must bring their own bedding.
- Q11. Is float plane and barge the only means of access to this site?
- A11. There is no road access.
- Q12. There is a note on AS-102 that refers to aluminum modular railing. There do not seem to be specifications for this, are you wanting aluminum prefabricated railing per the attached for this or is structural steel acceptable?
- A12. The hand rail must be aluminium.
