QUESTION AND ANSWER SERIES 1:

Q1. With regards to item number 45, code: MATS-01, the product description states 6' rolls with a quantity of 505. The specification is unclear, can Public Services and Procurement Canada clarify?

A1. The 505 indicates the total square feet area. The mats are to be joined seamlessly. The Contractor must provide the number of rolls required to cover the proposed area shown on the drawings, as well as the cutting around the columns.

Q2. The mandatory requirements for item numbers 6.0 through 10.0 (codes BNCH-01 through BNCH-05) indicate "Set back solid plate dark bronze legs at each end with finish to match bronze project control sample." Can a standard bronze finish be used for pricing?

A2. The pricing is to be based on custom oil rubbed dark bronze. The control sample will be provided at project award.

Q3. Please clarify the following discrepancies between what is stated in Attachment 1 to Annex A and the drawings for item numbers 6.0 and 8.0 (codes: BNCH-01 and BNCH-03). They are as follows:

BNCH-01

Attachment 1 to Annex A states 112" long, but the description and drawing add up to 132" long.

BNCH-03

Attachment 1 to Annex A calls for 2 seats with backs, 1 seat without, 1 table in between at 12" and 1 table at 30". However, the drawing shows a 132" long bench with 3 backless seats and a 42" wide table top.

A3. For BNCH-01 the Bidders must follow the drawing description (132" long).

For BNCH-03 the Bidders must follow what is specified in Attachment 1 to Annex A as the mandatory requirements (2 seats w/ backs, 1 seat without, 1 table in between at 12" and 1 table at 30"), the BNCH-03 graphic shown in the drawing is incorrect.

Please note: Bidders must be aware that any changes to Attachment 1 to Annex A resulting from Amendment 001 are also to be equally applied to Attachment 1 to Annex B **AND** to Annex 1 to Part 4.

ALL OTHER TERMS AND CONDITIONS OF THE REQUEST FOR PROPOSAL REMAIN UNCHANGED.
