## **SCOPE OF WORK / DELIVERABLES**

1. Work under this Contract includes but is not limited to the provision of all labour, materials, and equipment required to:
  - a. Mobilize to site with a work barge of appropriate size and certification;
  - b. Salvage:
    - i. Existing ATON appurtenances (lantern, solar panels, batteries and battery box); and,
    - ii. Existing ATON tower.
  - c. Remove and dispose of existing hand rails (building and pier cap);
  - d. Remove and dispose surplus abandoned utilities;
  - e. Demolish and remove existing building;
  - f. Complete pier repairs as detailed, including:
    - i. Partial depth removal of existing concrete;
    - ii. Concrete patching; and,
    - iii. Concrete crack sealing.
  - g. Install new reinforced concrete foundation above existing pier cap.
  - h. Install new 9.75m ATON tower
    - i. Tower has been fabricated with a splice ring and may be installed in two sections.
  - i. Install salvaged ATON equipment (Lantern/Solar Panels/Batteries).
  - j. Demobilize.
  
2. The following work will be undertaken by others and is hereby excluded:
  - a. Application of hand rail coating;
  - b. Supply of the new ATON tower; and,
  - c. Connection and commissioning of ATON equipment.

## **FAMILIARIZATION WITH SITE**

Before submitting a bid, bidders can visit the site (though this is not mandatory) and its surroundings, at their own expense to review and verify the form, nature, and extent of the work, materials needed for the completion of the work, the means of access to the site, severity, exposure and uncertainty of weather, soil conditions, any accommodations they may require, and in general shall obtain all necessary information as to risks, contingencies and other circumstances which may influence or affect their bid. No allowance shall be made subsequently in this connection on account of error or negligence to properly observe and determine the conditions that will apply.

### **EXPECTED START AND COMPLETION DATES**

The services of the Contractor will be commencing upon award of the contract. The expected completion date of this project is **October 31, 2017**.

### **MANDATORY REQUIREMENTS:**

- The minimum acceptable amount of Public Liability and Property Damage Insurance is \$2,000,000.00 per occurrence. All tenders **must** be accompanied by confirmation from the tenderer's insurance company that the required insurance will be available upon contract award;
- The tenderer must provide tender security, at the tenderer's own cost, in accordance with the document entitled "Tender Security Requirements" as Bid Security is required for bids over \$100,000. Under these circumstances, the Tender and **original signed Bid Bond** must be delivered to the Closing Location prior to the closing date.

**Note:** All tender securities (Bid Bond) will be returned except that of the successful tenderer (Bidder), which will be retained until the successful tenderer (Contractor) has completed the said contract.
