This solicitation amendment 017 is issued to answer questions raised from the Industry.

Q1 There are several references in the French DDP regarding the firm's experience with laboratory construction projects (eg 4.1.1 and 4.1.2). These references are non-existent in the English version. Please make a ruling to this effect.

*R1 The references to laboratory spaces in the French version of the RFP have been inserted incorrectly. The laboratory spaces that do exist in these subject buildings are the responsibility of the occupant department, Environment Canada, and are not included in this requirement.*

Q2 With reference to the scoring and scoring grid in ERPE 6, is it possible to specify your assessment and scoring methodology for the criterion of Canada's contribution to capital costs? For example, is the smallest amount systematically awarded the best score or is the evaluation based on the scope of the work included in the proposal?

*R2 Specific details in the evaluation of the Capital Cost Contribution, (CCC) are not available to Bidders. It should be noted however that PSPC has determined that in order to attain the mandatory GHG reductions contained within the RFP for each building, that funding in the form of an additional Capital Cost Contribution may be necessary. As such, PSPC has determined a notational value for the CCC for evaluation purposes only. Any request for CCC, (to remain within the stated 120 month payback period of the project) that is below this notional threshold will receive full marks.*
