# Part 1. Interpretation

- **1.1** Elections Canada hereby amends in accordance with this amendment the Request for Proposal (RFP) for Voting Services Modernization / Polling Place Process Enhancement bearing number ECRS-RFP-16-0167 and dated June 22, 2017 (the "RFP"). This amendment hereby forms part of the RFP.
- **1.2** Unless defined herein or unless the context otherwise requires, all of the words and phrases defined in the RFP and used in this amendment shall have the same meanings assigned to them in the RFP.

# Part 2. Questions and Answers

The following question(s) have been asked in response to the RFP and Elections Canada hereby answers as follows:

# 2.1 Question No. 1

# Question:

We have begun to review the detailed requirements and are very interested in pursuing this opportunity. Our review will take time and it will take time to determine if we can mount a compliant proposal. With the vacation period upon us and the complexity of the RFP, we know that we will require a significant extension to the close date. In fact we believe we will need at least an extra month. We are not ready to formally request an extension until our review is fully complete; however we would appreciate knowing if Elections Canada is in a position to grant such an extension. If there is very little flexibility in the close date, we may not be in a position to bid.

# Answer:

Elections Canada hereby extends the RFP closing date to September 7, 2017 at 2:00pm (Gatineau Time).

It should be noted that Elections Canada's schedule for the deployment of the E-Poll Solution is based on a fixed date, with significant integration, quality assurance, testing and other readiness activities which must be completed well before the start of the 43rd General Election.

As such, amending the RFP closing date does not reflect any date adjustments in the deployment schedule of the E-Poll Solution.

# Question:

Given the extreme size and magnitude of this RFP, we feel that the standard period of 45 days to produce a quality and detailed response is clearly insufficient. To this end, we request that the RFP closing date be extended by an additional eight (8) week period. Can Elections Canada please confirm this?
