In-Service Support of the *Halifax*-class Combat Systems
Amendment no. 016

This amendment is raised to provide the following update on the *Halifax*-class Combat Systems (HCCS) project:

Canada reaffirms its requirement for a single In-Service Support Contract (ISSC) provider for the *Halifax*-class Combat Systems.

Canada would like to thank all of the companies that provided valuable feedback during the One-on-One sessions held in May/June 2017.

Canada intends to proceed directly to a Request For Proposal (RFP) and will not release another Invitation To Qualify for this requirement.

Based on the feedback received, Canada expects to hold working group sessions with Industry to develop key aspects of the HCCS RFP and the Industrial and Technological Benefits Value Proposition (ITB/VP). These working group sessions are anticipated to be held in the National Capital Region in the fall of 2017. Anticipated topics for discussion include the Contract Terms and Conditions, Basis of Payment, Bid Evaluation, Performance Work Statement, Performance Requirements Specification and ITB/VP.
