

The purpose of this amendment is to:


1) Respond to bidder questions

1) Response to bidder questions (Q&A)

- QUESTION 1: I have tried searching for this within the RFP but when a company is awarded the contract are they expected to supply connection as of January 1 or later? When is the expected start date behind the initial service order?
- ANSWER 1: Once the contract is awarded, the winning contractor(s) are required to provide services immediately. SSC's plan is to migrate all existing non-SSC contracted services on a site by site basis to this new contract. There is no specific start date and the program will continue until all the non-SSC contracted services are migrated. It is the intent to complete the migration program before the end of the government fiscal year (i.e. March 31, 2018). Service orders will be issued for all new requests for new sites on a case by case basis.

QUESTION 2: Should Form 7 be submitted to the email at the bottom of it or included in the bid? Also, where do we find all of the "Integrity clauses included in the contract" (The ones listed July 2012, March 2014, November 2012, etc)

- ANSWER 2: Bidders must include Form 7 in the bid proposal. Integrity clauses is available in Buy and Sell web site. https://buyandsell.gc.ca/policy-and-guidelines/
- QUESTION 3: As for the Security Requirement Checklist, are we simply just including that within our bid as is? Already filled out?
- ANSWER 3: Bidders shall note that the reference to Shared Capacity Satellite Service Stream 1 and 2 for SSC Request for Proposal at page 26 of the RFP Section 6.1, Security Requirement and page 33 of the RFP Section 7.7
