This amendment 001 is raised to incorporate the following changes to solicitation 21520-184620/A Laundry:

1. Refer to Annex "B" Basis of Payment, and add the following information:

"Prices Quoted do not include Applicable Taxes. Applicable Taxes will be added as a separate line item on any invoices issued against this contract."

2. Questions and Answers:

Q1: Is the maintenance of dispensers optional on this tender or mandatory? It is worded in a manner that that the maintenance may be optional.

A1: Annex "A" states that "Routine maintenance of the dispensing system (if provided by the successful bidder) is to be included at no cost to CSC." In other words, if the supplier's bid includes supplying their own dispensers, routine maintenance would need to be included as well. If the supplier chooses not to provide their own dispensers and supplies products compatible with the customer owned equipment, routine maintenance would not need to be included in the bid.

Q2: Is the 72 hour maintenance call outs to be quoted outside the cost per litre or factored into the price?

A2: If the bidder provides the dispensers the cost of the call outs would need to be included in the cost per litre, it would not be an additional cost to the customer.

Q3: Is there a call out frequency history available if the cost is blended?

A3: Callout has been infrequent when using the current customer owned equipment – every six months would be typical maintenance required to replace squeeze tubes on customer owned equipment.

Q4: Are there redundant dispensers for each washing machine if a dispenser goes down to minimize frequency of call outs?

A4: No, there are no redundant dispensers.

Q5: Are these dispensers facility owned, it states that the current chemical provider used the Knight single shot, if this tender is awarded to another vendor does the new vendor need to supply dispensers?

A5: The new vendor would have a choice – bid on products compatible with the customer owned Knight dispensers or provide their own dispensers to replace the customer owned equipment. If the new vendor provides their own dispensers they would also need to install them.

Q6: Do you require a cost for additional dispensers above the 50 units mentioned?

A6: The cost does not need to be itemized separately but the vendor would be expected to provide them at no cost to the customer.

Q7: Are there any special shipping requirements or restrictions, power lift gate, docks, forklift accessibility or truck size limitations?

A7: The product would need to be offloaded at our existing loading dock. A forklift will be available for unloading, as would pallet jacks.

Q8: Destination is all at the one facility in Prince Albert? Or are there 2 facilities because the consumption is broken down into 2 parts?

A8: Prince Albert is the single destination. It is only broken into two parts due to the two different size of pails/jugs that are required.

Q9: Q-what is the Model number for knight single shot in use at CSC, as there are internal/ external transformer options and remote start options?

A9: Model #8600201-p1 with external transformer.

Q10: Are 11 litre pails acceptable for 1700 litre consumption options? My packaging providers only have 11 litre options.

A10: 11 litre pail will be fine.

All other terms and conditions remain unchanged.
