1.0 ARCHITECTURAL SPECIFICATIONS

1.1 Refer to: Section 01 11 00, Summary of Work,

Add:

- 1.3.3 Construction work of the bike trail by a separate contractor outside the project areas of the 4 washrooms at the beaches (Incinerator Rock, Wickaninnish Beach, Long Beach North and South Location) will be carried out at the same time as the plaza construction around the 4 washrooms. Contractor to coordinate with the bike trail contractor regarding the transition of site grading, material and installation at the interface of the individual project area.

2.0 QUESTIONS

Q1. What brand of electrical panel is in the electrical kiosks at Green Point Campground? 400amp breaker is required. Push-in or bolt-on?

A1. Panels are Square 'D' with bolt-on circuit breakers.

Q2. Who is supplying the hand dryers for the washrooms?

A2. Supply and Installation of Hand dryers is part of contract. Refer to Specification Section 10 28 10 Toilet and Bath Accessories Item 2.3.14.

Q3. Are we able to connect to a main power source on site if we allow for cost of temporary pole and connections?

A3. Yes.

Q4. Is it acceptable to park an RV on site to accommodate our site superintendent during construction?

A4. No.

Q5. The hazardous waste report identifies where lead paint is present, but does not specify if the lead paint is leachable or not. Please confirm we are to assume the lead is non-leachable and additional costs for disposal will be addressed during construction if found to be different.

A5. Yes.
