Arrangements have been made for the site visit to be held at **NANAIMO / NANOOSE BAY, (CFMETR Nanoose Bay), BC on JULY 25 2017. The site visit will begin at 0945 hrs.** The Bidders Conference will take place immediately following. The scope of the requirement outlined in the bid solicitation will be reviewed during the conference and questions will be answered. It is recommended that bidders who intend to submit a bid attend or send a representative.

Bidders must communicate with the Contracting Authority no later than **JULY 20 2017** confirm attendance and provide the name(s), and driver's license numbers of the person(s) who will attend, along with the name of the company.

Bidders who do not confirm attendance and who do not provide the name(s) of the person(s) who will attend as required will not be allowed access to the site. Bidders will be requested to sign an attendance sheet and must bring photo identification, such as a driver's license.

No alternative appointment will be given to bidders who do not attend or do not send a representative. Bidders who do not participate in the visit will not be precluded from submitting a bid. Any clarifications or changes to the bid solicitation resulting from the site visit will be included as an amendment to the bid solicitation.
