#### **Description of Work:**

Health Canada requires the services of two (2), Platform Analysts - level 2, one (1) Platform Analyst - level 3, one (1) Technical Architect level - level 3 and one (1) Project Manager IT - level 2 in order to obtain informatics professional services to assist Health Canada (HC) and the Public Health Agency of Canada (PHAC) in the implementation of a stable SAS environment, at a supported Shared Services Canada (SSC) legacy data centre, which will allow for:

- essential expansion to accommodate for the current and growing user base;
- installation of licensed HC/PHC Statistical Analysis System (SAS) products, including the provisioning of development and test environments; and
- integration with and migration of other key HC and PHAC initiatives (e.g. Open Data Initiative, Data Extraction and Analysis (DEXA) System, Data Analysis and Information System (DAIS) and Global Public Health Intelligence Network (GPHIN)) onto the SAS infrastructure.

Resources will also be allocated to assist with the ever-greening and upgrade of the First Nations Inuit Health Branch (FNIHB) SAS Fraud Framework for Health Care Solution, known within FNHIB as the Fraud Detection Solution (FDS); and to assist with the planning and preparation for the eventual migration over to the Government of Canada (GC) SAS Cluster (multi-tenant) environment.
