PART 1 - GENERAL INFORMATION

1.1 Security Requirements

There is no security requirement associated with this bid solicitation

1.2 Statement of Work

2.1 Standard Instructions, Clauses and Conditions

2.2 Submission of Bids

Bids must be submitted only to Fisheries and Oceans Canada (DFO) Bid Receiving Unit by the date, time and place indicated on page 1 of the bid solicitation.

Due to the nature of the bid solicitation, bids transmitted by facsimile to DFO will not be accepted.

2.3 Former Public Servant

Contracts awarded to former public servants (FPS) in receipt of a pension or of a lump sum payment must bear the closest public scrutiny, and reflect fairness in the spending of public funds. P-36, and any increases paid pursuant to the <u>Supplementary Retirement Benefits Act</u>, R.S., 1985, c. S-24 as it affects the PSSA. It does not include pensions payable pursuant to the <u>Canadian Forces Superannuation Act</u>, R.S., 1985, c. C-17, the <u>Defence Services Pension Continuation Act</u>, 1970, c. D-3, the <u>Royal Canadian Mounted Police Pension Continuation Act</u>, 1970, c. R-10, and the <u>Royal Canadian Mounted Police Superannuation Act</u>, R.S., 1985, c. R-11, the <u>Members of Parliament Retiring Allowances Act</u>, R.S. 1985, c. M-5, and that portion of pension payable to the <u>Canada Pension Plan Act</u>, R.S., 1985, c. C-8.

Items identified as "proprietary" will be treated as such except where Canada determines that the enquiry is not of a proprietary nature. Canada may edit the question(s) or may request that the Bidder do so, so that the proprietary nature of the question(s) is eliminated, and the enquiry can be answered to all bidders. Enquiries not submitted in a form that can be distributed to all bidders may not be answered by Canada.

2.5 Applicable Laws

If there is a discrepancy between the wording of the soft copy and the hard copy, the wording of the hard copy will have priority over the wording of the soft copy.

Prices must appear in the financial bid only. No prices must be indicated in any other section of the bid.

Canada requests that bidders follow the format instructions described below in the preparation of their bid:

- a) use 8.5 x 11 inch (216 mm x 279 mm) paper;
- b) use a numbering system that corresponds to the bid solicitation.



The Contractor must comply with the insurance requirements specified in Annex C. The Contractor must maintain the required insurance coverage for the duration of the Contract. Compliance with the insurance requirements does not release the Contractor from or reduce its liability under the Contract.

The Contractor is responsible for deciding if additional insurance coverage is necessary to fulfill its obligation under the Contract and to ensure compliance with any applicable law. Any additional insurance coverage is at the Contractor's expense, and for its own benefit and protection.

The Contractor must forward to the Contracting Authority within ten (10) days after the date of award of the Contract, a Certificate of Insurance evidencing the insurance coverage and confirming that the insurance policy complying with the requirements is in force. For Canadian-based Contractors, coverage must be placed with an Insurer licensed to carry out business in Canada, however, for Foreign-based Contractors; coverage must be placed with an Insurer with an A.M. Best Rating no less than "A-". The Contractor must, if requested by the Contracting Authority, forward to Canada a certified true copy of all applicable insurance policies.

ANNEX "A" STATEMENT OF WORK

TITLE

Vessel for Natural Resource Canada's 2017 Arctic Marine Geoscience Seabed Survey

CONTRACTING PERIOD

Project work will take place over 40 consecutive days anytime from September 1 2017, through October 20, 2017, and will consist of 35 working days at sea.

OBJECTIVE

Natural Resources Canada (NRCan) is seeking availability of a commercial Oceanographic Research Vessel to conduct marine Geoscience research offshore northeastern Canada. Specifically, an Oceanographic Research Vessel is required for 40 consecutive days sometime from September 1 through October 20 2017, as per the following time requirements:

- Mobilization at Port of Halifax, Nova Scotia, CANADA 3 days
- Marine Geoscience cruise in Davis Strait, Hudson Strait, Foxe Basin, and Baffin Bay 35 days at sea
- Demobilization at Port of Halifax, Nova Scotia, CANADA 2 days

The survey needs to be conducted during this time period as ice-free waters are required for the types of sampling to be conducted.

BACKGROUND

The objectives of the expedition to Baffin Bay, Davis Strait, Hudson Strait, and Foxe Basin are to improve understanding of the surficial geology, seafloor properties, and processes on the continental shelf and slope. Specifically:

- 1. Assessment of regional surficial geology framework in the area. This includes the seabed sediments and shallow subsurface bedrock, as well as their physical properties.
- 2. Investigation of targeted seabed features in the study areas, including known and potential seabed hydrocarbon seeps.

Fieldwork will be continuous during the specified dates, less the time it takes to transit to/from the field site. It will be a 24-hour per day operation. In general, sampling work will occur during the day and hydroacoustic surveys at night. On occasion, hydroacoustic surveys will be 24 hours per day. The work sites are located in remote locations in Nunavut waters up to 200 nm offshore and in water depths up to 3000 m.

- <u>Sediment sampling</u> during the day is to include: primarily piston coring, along with some dredge samples and seafloor photography/video. Cores are to be processed on board the vessel, with physical properties and hydrocarbon indicator measurements to be taken in the lab by NRCan personnel. Core sections will be sealed and stored in a refrigerated container until the ship returns to Halifax.
- Hydroacoustic surveys during the night (and sometimes during the day) are to include: high
 resolution sub-bottom 3.5 kHz surveying and multibeam bathymetry data collection. Seafloor
 photography at night may also be required.

REQUIREMENTS

The Statement of Work outlines all mandatory requirements that an Offshore Research Vessel is to include to be considered capable of completing the NRCan 2017 Arctic Marine Geoscience Seabed Survey research cruise.
