AMENDMENT 001

In regards to solicitation EE517-173360/A, please take note of the following questions and answers as well as a modification in connection with question #4:

Question #1:

In regards to solicitation EE517-173360/A, can the proposed Project Director be the same person than the proposed Project Manager?

Answer #1:

No, they have to be two different persons. For these projects, we require a team composed of different persons who have distinct responsibilities with their own tasks related to those responsibilities.

Question #2:

Annex B – Basis of payment: The slip provides for two (2) names for the project director as well as the project manager. Please specify if PWGSC considers 2 options for this role depending of the type of mandate or if this is for a main and a replacement?

Answer #2:

As indicated in Section 1 - Mandatory Technical Criteria of Attachment #1, the offeror must propose a minimum of one project director (...) and a minimum of one project manager (...). It is the responsibility of the offeror, *if he decides* to propose more than one resource for each type of the requested resource, to make sure that its offer meets the requirements of the Request for Standing Offer.

Question #3 :

1.5 – References: Please confirm if the projects concerned by the references (Annex c) must be completed. Give precisions concerning the value in the evaluation for additional references?

Answer #3:

As mentioned in Section 2.3 – Projects of the firm of attachment #1, every proposed projects must be completed at the closing date and, executed in the last five years. The references to be provided that are mentioned in Section 1.5 of Part 5 must concerned the projects that are presented in Section 2.3 – Projects of the firm of Attachment #1. All technical point-rated criteria for the projects of the firm are presented in Table 2 of Section 2 of Attachment #1.

Question #4:

In the Request for Standing Offers EE517-173360, it is asked at point 2.3 – Projects of the firm, that the 10 projects that are presented be accompanied by the offeror letter of references (Annex C). However, in Section 1.5 – References, it is stated to provide a minimum of 5 references from 3 different clients for projects of more than 25,000.00\$ and needing a team of more than 2 persons.

In the case of the Request for Standing Offers EE517-173361, it is not requested to provide references for the 10 projects of the firm. It is understood that the references are limited to the terms of Article 1.5 – References (identical in the two documents). Is it possible to determine the number of references that PWGSC wishes to obtain and if it is applicable only to the 10 projects of the firm or if the references can cover other distinct projects?

Answer #4:

For the two Requests for Standing Offers (EE517-173360 and EE517-173361), the requirement is to provide a minimum of 5 references coming from 3 different clients for projects of more than 25,000.00\$ and needing a team of more than 2 persons. All the projects which are presented in Section 2.3 of Attachment #1 do not need to be the object of references. References (a minimum of 5) only apply to the projects presented in Section 2.3 of Attachment #1.
