Solicitation Amendment 001 is posted to respond to Bidder questions as follows:

- Q1:** Is there a difference between item 26E011 (Smokies, Bavarian) and item 26E018 (Sausage Bavarian, Smokie)?
- A1:** *It is the same type of product, but a different case lot size is requested.*
- Q2:** Can items 10B003 (Chicken Strips, Breaded), 10B010 (Chicken Fingers, Breaded) and 10B081 (Chicken Fingers, White Meat, Breaded) be the same product?
- A2:** *Yes; vendors may propose the same type of product for these 3 unitrak codes, but must be different brands. This product must be 100% white meat breaded chicken fillet, **not** ground formed and breaded.*
- Q3:** Can item 10B116 (Chicken Supreme) be the same product as 10B081 (Chicken Fingers, White Meat, Breaded)? Is there a specific distinction that you require?
- A3:** *Item 10B116 **cannot** be the same as 10B081. The requirements for item 10B116 are Deboned, Half breast, Skin on, Wing bone in.*
- Q4:** Is item 12A010 (Bacon) the same product as 12A013 (Bacon, Sliced, Regular)? Is there a specific distinction that you require?
- A4:** *Vendors may propose the same type of product for item 12A010 and item 12A013, but must be different brands. This product must be Sliced Bacon 16-18 center cut.*
- Q5:** For item 15B005 (Lobster, Rock, Tail), is there a preference for size and warm water/cold water?
- A5:** *Item 15B005 must be warm water as it is typically a cheaper product and offered in 3-6 oz. sizes.*
- Q6:** For item 15B018 (Lobster, Tail), is there a preference for size and warm water/cold water?
- A6:** *Item 15B018 must be cold water Atlantic and offered in 3-6 oz. sizes.*
- Q7:** For item 15B030 (Scallops), is there a preference for size?
- A7:** *21/25*
- Q8:** Is there a difference between item 15C007 (Shrimp, Breaded, Butterfly) and item 15C017 (Shrimp, Breaded, Fan Tailed 21 / 25 count)?
- A8:** *The case sizes are different. Having 2 different product sizes is acceptable and desired.*

Q9: For item 9C013 (Beef, Burger), is there a specific size of burgers requested?

A9: *6 oz. 100% beef minimal shrink.*

Q10: For item 9C046 (Beef Burger, Outlaw), is Outlaw the specified brand of burger?

A10: *Any comparable 5 oz burger patty is acceptable.*

Q11: For item 9G001 (Beef, Sirloin Steak, Boneless), is there a specific size of steak requested?

A11: *Portion size standard requires a 180g (6 oz) raw product.*

Q12: For item 3A038 (Bread, Baguette, Bake and Serve), is a specific size required?

A12: *365 g is requested.*

Q13: For item 3F011 (Croissants), is a specific size required?

A13: *42 g is requested.*

Q14: For item 32A440 (Lettuce, Summer Mix), is there a preferred mix (varieties) of lettuce?

A14: *No; a mix of lettuce with fewer greens of other types – Red Leaf, Green Leaf, Butter, etc.*

Q15: For item 32B021 (Lettuce, Mesculin & Spring Mix), is a whole lettuce or a washed and cut blend preferred?

A15: *The product required here is a mixed greens containing lettuce – Mesculin is a mix of sweet lettuces and tangy, tender greens like spinach, arugula, Swiss chard, mustard, endive, etc.*

Q16: Is there a preferred list of vegetables for item 32B117 (Vegetables Mixed, Roast)?

A16: *Root vegetables that roast well, e.g. butternut squash, onions, carrot.*

Q17: Is item 5A060 (Avocado) the same product as item 5A207 (Avocado, Hass, Fresh)?

A17: *Yes; the case lot is different.*

Q18: Is there a preferred mix of vegetables for item 32C024 (Mixed Vegetables, Parisienne, Frozen)?

A18: *The Arctic Gardens brand Parisian blend contains Carrots, Green Beans, Cauliflower and Onions. Something similar would be acceptable.*

Q19: Is there a preferred mix of vegetables for item 32C095 (Mixed Vegetables, Garden, Frozen)?

A19: *The Arctic Gardens brand Mixed Vegetable contains Carrots, Green Beans, Super Sweet Corn and Peas. A similar blend would be acceptable.*

Q20: Is there a preferred mix of vegetables for item 32C109 (Mixed Vegetables, Harvest)?

A20: *Carrots, corn, and green beans.*

Q21: Is a specific size of shell required for item 3A015 (Pizza Crust, Plain, Frozen)?

A21: *16 inch is required.*
