7. Mandatory Site Visit

It is mandatory that the Bidder or a representative of the Bidder visit the work site. Arrangements have been made for the site visit to be held at 455 Boulevard de la Carriere, Louis St-Laurent II, Gatineau, Quebec on July 27, 2017. The site visit will begin at 09:00 a.m. Eastern Daylight Time, in the main entrance.

Bidders must communicate with the Contracting Authority no later than 05:00 p.m. Eastern Daylight Time on July 24, 2017 to confirm attendance and provide the name(s) of the person(s) who will attend. Bidders will be required to sign an attendance sheet. Bidders should confirm in their bid that they have attended the site visit. Bidders who do not attend the mandatory site visit or do not send a representative will not be given an alternative appointment and their bid will be declared non-responsive. Any clarifications or changes to the bid solicitation resulting from the site visit will be included as an amendment to the bid solicitation.
