1. **UPDATES to the RFP Document:**

Please note the following changes:

1. **OMIT SRE02 SUBMISSION REQUIREMENTS AND EVALUATION** from **SUBMISSION REQUIREMENTS AND EVALUATION (SRE) – REVISED JULY 17, 2017** and **REPLACE** with the following:

SRE 02 SUBMISSION REQUIREMENTS AND EVALUATION

Bidders' responses will be assessed in accordance with the entire requirement of the request for proposal document including the technical and pricing Evaluation Criteria. An evaluation team composed of representatives of Canada and Herold Engineering will evaluate the proposals.

Each responsive proposal will be evaluated against the mandatory criteria and point-rated criteria listed below. The information should be detailed enough so as to allow a complete evaluation. It would assist in the evaluation if each section clearly indicates the specific criteria it is addressing.

For each rated criterion where a maximum number of points is shown, evaluators may award any even, whole number in the range of points from zero up to the maximum number of points.

Bidders' responses will be evaluated against the definitions and information requirements as described by these Evaluation Criteria. Bidders should ensure that all responses provide the necessary details regarding dates, education and credentials, and demonstrative project experience. Points will be awarded solely on the basis of information as explicitly written in the Bidders' response. Once individual evaluations by the evaluation team have been completed an attempt to reach a consensus score will be conducted under the observation of the Fairness Monitor and Contracting Authority. If a consensus score cannot be reached, an average score from all evaluators will be taken as the overall score for each point-rated criteria.

2. **OMIT 1.0 a) (2) of SUBMISSION REQUIREMENTS AND EVALUATION (SRE) – REVISED JULY 17, 2017 and REPLACE** with the following:

On the cable schedule (drawing E4) there are 4 cables listed (under Tug Wharf Cables, Nav Lights) but only 3 labels. Please advise.

On drawing E4 in the cable schedule table under Tug Wharf Cables, Nav Lights service change conductor 2x2c#8 TC Cable to 1x2c#8 TC Cable for 1NAVLT.

Question 2:

Further to a previous question, the manufacture name and contact information for the "sole source" bollards and cleats have been removed from the drawings, however their proprietary model number is still included on the drawings, leading one to believe that these items are still expected to be sole sourced from the previously identified manufacturer.

Answer 2:

On drawing S28 remove the note "Model No. A-19" from the 100 Tonne Bollard detail, and on drawing S29 remove the note "Model No. B-2X" from the 34 Tonne Cleat detail.

Question 3:

Drawing E3, cable 40WHT was dropped when the duct bank turned the corner (from SJL to SJX).

Answer 3:

On drawing E16 in the cable schedule table for SJX conduits, add cable identification 40WHT to conduit 1-1, so that conduit 1-1 has 6HM1, 2HM and 40WHT cables.
