**Q1:** Question regarding **Annex “A”, Statement of Work, 4) Stock on (page 18)**: the document states the stock requested for the Cover to be Supreme gloss 130lb. Is this text weight or cover weight (it doesn't mention stock weight)? Text weight is only available up to 115lb, but cover weight does come in 130lb – can you confirm text weight or cover weight, please?

**A1:** Cover weight, supreme gloss 130 lb

**Q2:** I'm looking for clarification on the answer given for Q1 of Amendment No. 001 which was posted on July 12, 2017

In the answer (A1) there is no mention of PMS 032. Has the PMS requirement been dropped from this request making this a straight 4/4 print requirement?

**A2:** Yes, the PMS requirement has been dropped.
