This solicitation amendment is raised extend the tender closing date and to address tender related questions submitted by contractors. All other terms and conditions remain unchanged.

Extension of Time for Tenders

Notice is hereby given that the time for reception of tenders previously due at 2:00p.m. local time – July 27, 2017 is extended to 2:00p.m. local time – **August 8, 2017.**

Questions:

Q1. The prescribed Bid Bond form as related to BA07 of the Bid and Acceptance Form indicates a validity period of (60) days however BA04 of the Bid and Acceptance Form states a validity period of (30) days. Please confirm which is correct.

A1. BA 04 in the Bid and Acceptance Form states:

“The bid shall not be withdrawn for a period of thirty (30) days following the date of solicitation closing.”

Form PWGSC-TPSGC 504 Bid Bond, subparagraph a. of CONDITIONS OF THIS OBLIGATION where it states

“ the Principal, should his tender be accepted within the period be specified by the Crown, or, if no period be specified, within sixty (60) days after closing date of the tender, does execute within a period specified by the Crown, or, if no period be specified therein, within fourteen (14) days after the prescribed forms are presented to him for signature, execute such further contractual documents, if any, as may be required by the terms of the tender as accepted, and does furnish a Performance Bond and a Labour and Material Payment Bond, each in the amount of 50% of the Contract price and satisfactory to the Crown, or other security acceptable to the Crown”

BA 04 in Bid and Acceptance Form already stated thirty (30) days.

Q2. Amendment #6, the response to question #2 should clarify that all subcontractors must identify the PST amounts that need to be deducted or added from/to their base bids.

A2. Please refer to the Certification of Exemption – Subcontractor (FIN 493) included in the Provincial Sales Tax Bulletin dated October 2015 for details.

British Columbia Provincial Sales Tax Act - Real Property Contractors

Real property contractors in the Province of British Columbia who have contracts with the Federal Government may make purchases for use in real property contracts exempt of Provincial Sales Tax (PST) by providing their suppliers with a completed Certificate of Exemption – Contractors (FIN 491) and, if necessary a completed Certification of Exemption – Subcontractor (FIN 493).

Upon request, Canada will provide the General Contractor with a duly signed exemption form, FIN 491 and if applicable FIN 493.
