1. All questions comments regarding this tender shall be sent to Mony Lee at PSPC (Mony.Lee@tpsgc-pwgsc.gc.ca)
2. The customer metering is believed to be ahead of the utility meter based on the information we received previously from Flyer Electric. A shut down is required for correction of this issue. If this condition is not present upon opening of equipment further discussion will need to be held with the Environment and Climate Change Canada (Owner). If the customer metering equipment cannot be relocated then it will have to be removed and/or further discussion will be needed with the Owner.
3. Electrical outages should be kept to a minimum
4. 72 hour notice required before an electrical shut down
5. Typical business hours are Monday to Friday 08:00h to 16:00h
6. 48 hour notice required before any work outside of typical work hours
7. Jack hammering and any other loud work shall be conducted outside of typical business hours
8. 2 to 3 parking spots will be available for contractors use

9. Contractors may use site washrooms
 10. Routing of new/existing equipment shown on drawing and walked through on site
 11. Existing capacitor bank may need modification to fit through existing doorways
 12. Existing customer metering accuracy to be verified as switching in and out steps in the existing capacitor bank did not produce expected results.
 13. Floor finish shall match existing (Dark Gray)
