### A. Questions and answers

#### Q1:

I am former public servant who started her own consulting firm about 2 years ago.

Are there any restrictions for me to bid to become a vendor on the Learning Services SA?

Is there a requirement as to how many years my company needs to be in business?

I read in the document that I may be asked for proof that the company has been in business for at least 3 years. But there is no stated requirement as such.

#### A1:

A former public servant may bid during the Refresh Period of the Learning Services (LS) Request for Supply Arrangement (RFSA) and must complete the Former Public Servant Certification. Please note, if, as a result of this RFSA, a SA is issued, the name of the Former Public Servant will be posted on the LS web site. This information will also be on departmental websites as part of the published proactive disclosure reports generated in accordance with Treasury Board policies and directives on contracts with former public servants, Contracting Policy Notice 2012-2 (<https://www.canada.ca/en/treasury-board-secretariat/services/policy-notice/2012-2.html>) and the Guidelines on the Proactive Disclosure of Contracts (<https://www.tbs-sct.gc.ca/pol/doc-eng.aspx?id=14676>).

Yes, it is a mandatory requirement for your company to must have carried on business as the same legal entity for a minimum of 3 years as of the closing date of this RFSA solicitation. Please refer to the RFSA Refresh Period Bid Solicitation document, Attachment A to Component I for the Mandatory Technical Evaluation Criteria.
