## **Amendment 02**

This amendment is being raised to respond to questions asked at the optional site visit on July 12, 2017.

### **Site Visit Questions**

**Q:** Any utilities on site?

**A:** A survey has not been completed for utilities and will not be provided. The contractor is to call for underground utility locates. All utilities must be located in field prior to any excavation. Contact Saskatchewan 1st call at 1-866-828-4888.

**Q:** How will campsite layouts will be confirmed?

**A:** Site survey AutoCAD file may be supplied at contractor request after project award. Layouts to be completed by contractor and will be confirmed by consultant and/or departmental representative. Layouts will vary site by site dependent on site conditions, as this is predominantly a retrofit project.

**Q:** How will sequencing be handled on site?

**A:** Loops will be closed off to visitors during construction and contractors will have full access and control of those loops. See SUMMARY OF WORK spec section 01 11 00 for item #1.7 for Work Sequence.

**Q:** What is to happen to the existing vehicle stops at some of the campsites?

**A:** All timber vehicle stops to be removed and disposed of offsite by contractor.

**Q:** What is the protocol for the stump removal?

**A:** Stumps should be removed as required and as shown at the specified locations on the drawings. See PAYMENT PROCEDURES spec section 0129 00 for item #1.3 Unit Price Items and item #.5. Clearing and Grubbing – Grubbing Isolated Trees Stumps (Section 31 11 00).

**Q:** Where is the stockpile location going to be for the wood chips?

**A:** Location of wood chips and mulch goes to the "staging area" at the Narrows cut across road at Beartrap. Location to be confirmed by PCA. All non-salvageable felled timber to be removed and disposed of offsite.

**Q:** Can you clarify testing requirements and density requirements?

**A:** See specifications. Field Compaction Testing as described in Section 32 15 40 Crushed Stone Surfacing. See item 3.4 Field Quality Control for detailed information on execution.

**Q:** What are the weight limits on the roadways - loop roads and entrance roads?

**A:** The Park has no set limits of their own but the Saskatchewan provincial regulations for secondary roads will apply.

**Q:** Are contractors using Native Fill?

**A:** Acceptable if there is extra material from excavations and only if it is appropriate material. See specifications Section 31 14 13 SOIL STRIPPING AND STOCKPILING and Section 32 91 19 TOPSOIL PLACEMENT AND GRADING.

**GENERAL INFORMATION:**

- Contractor is to minimize disturbance throughout construction.
- Campsites were built in the 1960's. Not much work has been done since then other than some expansions and addition of electrical. This is not in regards to electrical for the campsites, as the sites do not have power pedestals at the Narrows.
- PCA will remove the trees within the expanded campsite areas prior to commencement of work.

**All other terms and conditions remain unchanged.**
