QUESTION AND ANSWER SERIES 2:

- Q4. In Attachment 1 to Annex A, item numbers 24.0 and 25.0 (Codes FILE-01 and FILE-02) have requested black pulls as part of the mandatory criteria; however, the metal series has never had pulls nor have there ever been any done as specials for a client. Can Public Services and Procurement Canada (PSPC) please clarify?
- A4. Both components (FILE-01 & FILE-02) have a fully integrated pulls, the full width of the cabinet which matches the color of the cabinet specified in Attachment 1 to Annex A.
- Q5. In Attachment 1 to Annex A, item number 25.0 (code FILE-02), the height specifications is for a unit just over 25 inches. This unit has been discontinued leaving a 27" high unit only. Can PSPC confirm if this is acceptable?
- A5. PSPC confirms this is acceptable. FILE-02 to be replaced with height of 27"15/16".
- Q6. In Attachment 1 to Annex A, item numbers 79.0 and 83.0 (codes STOL-02 and TASK-01) state the same model number, but have different mandatory criteria. Which model number is correct? And what is the model number supposed to be for the other?
- A6. The TASK-01 model number listed in Attachment 1 to Annex A (DR-D-F-96-SS-LU) is correct. STOL-02 should be revised to DR-H-E-96-250 (*DESIRE stool, H-high backrest, E-ergo 3 paddles, 96-multi-function & urethane pad, 250-drafting kit 10" stroke which can go from 23-3/4"-33-3/4" range*).
- Q7. Can PSPC clarify the mandatory criteria for item number 79.0 (STOL-02).
- A7. The Mandatory Technical Criteria is revised as follows: STOL-02 is to range between 23.75" and 33.75" which would have a product code of DR-H-E-96-250. Refer to revised product code DR-H-E-96-250 as identified in Q&A #7.
