Publish Canada's Responses to Bidders' questions, to amend the closing date of the RFQ and to amend the contract authority on the RFQ.

Question 5:

Are all the cables to be interchangeable between the 2 and 4 port KVM's? Or is the Crown accepting 2 different cables?

The same question for the Options quantity as well

Answer 5:

The KVM Cables must be interchangeable between the two KVMs. The Crown is not accepting 2 different cables for the KVMs.

Question 6:

Will the client be testing the units before the contract is awarded?

Answer 6:

As per Part 2 Section 2.6 Test Units in the RFQ, the client can request testing prior to contract award.

Question 7:

Could the 2 port DVI-I secure KVM Switch NIAP 3.0 be a 2 Port DVI-D secure KVM switch NIAP 3.0 with the DVI-D cables included?

Answer 7:

The 2 port DVI-I secure KVM switch NIAP3.0 has to be DVI-I.

Question 8:

Does the 4 Port Dual Link KVM require dual head or single head?

Answer 8:

Single Head

Question 9:

Does the Crown require that the switches be compliant with both NIAP PP 3.0 and EAL 4+ security certifications?

Answer 9:

Yes

Question 10:

Does the Crown require that the switches provide Num Lock, Caps Lock, and Scroll Lock indicators?

Answer 10:

Yes

Question 11:

Does the Crown require that the switches can prevent USB devices from switching between channels when changing sources?

Answer 11:

Yes

Question 12:

May you please expound further what it meant "a maximum of 3 amendments" on section 6.10 (b) of the bid stating: "Options to purchase the additional quantities...may be exercised through a maximum of 3 amendments per Identified User to the RFQ Contract, unless otherwise agreed to by the Contractor and the Contracting Authority, at any time within 24 months of the RFQ Contract award date.

Answer 12:

Within a year of the contract, the client can exercise the optional quantities. They do not need to exercise all the quantities in one amendment, so they have a maximum of 3 times to request an amendment to purchase additional quantities. If they exercise all their options in the first amendment then they cannot get any more. Also, there is no guarantee that the client will exercise options.

Questions 13:

On the option quantity items, are the quantities firm quantities? Or for example the 2-Port DVI-I Secure KVM Switch NIAP 3.0 which is 100ea, is it up to 100ea or firm 100ea?

Answer 13:

The quantity requested for the 2-Port DVI-I Secure KVM Switch NIAP 3.0 is 100 units. The client can exercise the initial client options and purchase up to 100 additional units.
