The contract will be awarded under the authorities of the Minister of Fisheries and Oceans pursuant to paragraph 180(1)a) of the Canada Shipping Act 2001. The aim of the contract is to exclusively eliminate any threat of pollution with the removal and dismantlement of the MV Kathryn Spirit. The amounts to be paid under this contract by Canada will be used to cover the costs and expenses of the contractor.

It is important to note that Canada is not the owner of the M/V Kathryn Spirit. The awarded contract will not constitute a divestiture nor a transfer of ownership of the vessel. Canada is not bound by any liens or privileges that might exist on the MV Kathryn Spirit. The contractor will therefore not be responsible for any such liens or privilege.

VA5) The last inspection was in 2009. This inspection was not conducted for the Canadian Coast Guard and we do not have the inspection report. Consequently, it cannot be made available to bidders.

VQ6) Has the Canadian Coast Guard validated the integrity of the vessel?

VA6) No, the Canadian Coast Guard did not conduct a study to validate the integrity of the vessel. Only localized interventions have been undertaken to inventory hazardous materials.

VQ7) Do you know the contents of the ballasts?

VA7) No, the ballast contents are not known precisely. We know, however, that the bulkheads are not watertight and that the water flows inside the ship.

VQ8) There appear to be groundwater sampling wells on the site. Is the data available?

VA8) Wells were installed by the landowner to ensure environmental monitoring with provincial authorities. We do not have data from these wells. It should be noted that the nature and concentration of contaminants present the in sediments and in the field are presented in the appendix to the Statement of Requirements.
