Unit Price Table Scenario A is for all work as shown on the drawings within Area A including work with the limits of new asphalt in Area B.

Asphalt pavement and concrete removal shall be measured by the linear metre and shall include all labour, materials and equipment necessary to complete the work within Area A and Area B for Scenario A and Scenario B with the exception that Scenario A does not include the removal of the existing concrete parapet within Area B.

Insert: New Clause, 1.2.7

Electrical power pedestal removal including concrete footings, conduits, junction boxes and wiring shall be measured by each pedestal removed and shall include all labour, materials and equipment necessary to complete the work within Area A and Area B for Scenario A and Scenario B. Reinstallation of the salvaged power pedestals salvaged wiring including new concrete footings, and conduit shall be considered included in the removals and will not be measured separately for payment.

Geogrid shall be measured in square metres of surface covered by material and shall include all labour materials and equipment necessary to complete the work within Area A and Area B for Scenario A and Scenario B. An allowance has been made for placing the geogrid in the existing steel sheet pile outpans and inpans and side slope. No allowance will be made for seams and overlaps.
