SOLICITATION AMENDMENT No. 003

This solicitation amendment No. 003 is raised to:

- 1) publish questions and answers that have been received in relation to this solicitation;

- 1) The following Questions and Answers have been provided:

QUESTION 1:

Do you require a total of 2 arm amputations and 2 leg amputations per manikin even if the vendor's amputation can be utilized on either the right or left arm/right or left leg?

ANSWER 1:

1 arm and 1 leg amputation per mannequin is sufficient as long as they can be utilized on either the left or right side.

QUESTION 2:

Do you require each manikin unit price to include a 1 year warranty, and vendors can outline the cost of the 3 additional warranty years separately? Or do you require each manikin unit price to include a 4-year warranty?

ANSWER 2:

Yes, each mannequin unit price should include the standard 1 year manufacturer warranty. An extended warranty is not required. After the initial one year, warranty, service, support and repairs are to be governed as per Annex "A" Statement of Requirement, paragraph 9.

ALL OTHER TERMS AND CONDITIONS REMAIN UNCHANGED
