AMENDMENT No. 1

This amendment aims to answer some questions received during the call for tender:

Q1: It is mentioned in section 4.3.1.1 that the consultant must present within his team a professional registered on the list of experts of the CEAEQ. If this expert is a separate person from the list of key personnel, how should the information be inserted in tables 1-1 and 1-2 of Annex B?

A1: The rate of the project director will be retained as the hourly rate of the CEAEQ expert.

Q2: Annex B - Payment Base Point 10 - Analytical Laboratory (p.51 of 63): It is stated that unit costs should include the supply of sample containers, preservatives, laboratory costs, etc. For the analysis of volatile organic compounds (VOCs, HAMS, BTEXs) in soils or sediments, sampling must be carried out using specific equipment (Syringe / TeraCore and methanol vials). This material is provided by the laboratory for a fee and applies to all samples taken regardless of whether they are analyzed or not, making it difficult for laboratories to include these costs in the assay price.

Is it possible to add an item to the slip for the supply of sampling equipment for VOCs or to specify that these costs are excluded from the VOC analysis price?

A2: The cost of the analysis must include the sampling equipment provided by the laboratory.
