Amendment 3

SNIC

This amendment was raised to answer questions:

1. On some of the maps there are blue cloud like shapes. Are these to be considered the locations where the snow can be piled?
 - A. The blue cloud like shapes are tentative locations for snow piles, based on previous SNIC seasons. Snow pile locations will be confirmed during the start-up briefing after contract award. SOW Clause 4.2 and 4.5.1.12
2. Where is the snow to be pushed on the laneway of the golf course?
 - A. Snow pile locations will be confirmed during the start-up briefing after contract award. SOW Clause 4.2 and 4.5.1.12
3. Will there be a pre-season inspection to document damages?
 - A. Yes, during the start-up briefing. SOW Clause 4.2.5
4. What is access like after hours and on weekend and holidays? What gates are closed?
 - A. There are three access points to Garrison Petawawa during normal business hours (0600hrs – 1800 hrs M-F). After hours and on weekends/holidays, the only access to Garrison Petawawa is through Maj Gen Frederick Gate on Menin Rd.
5. With the Pembroke Armouries located around businesses who do not report to DND what happens when their contractors or themselves push snow into the Armouries?
 - A. Report incidences to the PA who will address concerns with adjacent businesses.
6. Is it acceptable to utilize grass areas when there is no room for the equipment to traverse the sharp corners in the smaller laneways?
 - A. Only with prior approval from the PA. This will be discussed during the pre-season meeting. SOW Clause 4.2
7. When was the last time the “as and when” line items for the area was called up?
 - A. “As and when” areas are used when requested from the PA. There are estimated monthly usage figures in ANNEX “B” Basis of Payment; Pricing Basis “B”.

8. Are the concrete areas at the north end and south end of CC128 to be cleared of snow?
- A. Yes. As per SOW Clause 5.38.2 and 5.38.3.

All other terms and conditions of this Request For Proposal remain unchanged.
