TITLE – REQUEST FOR STANDING OFFERS–NATIONAL MASTER STANDING OFFER FOR AIR CHARTER SERVICES

This Amendment No. 004 is issued to amend the Request for Standing Offers – National Master Standing Offer for Air Charter Services (RFSO) as follows:

1. Publish the complete RFSO Amendment 004 as an attachment to this document, so that the hyperlinks in the document are active:
 - a. **Hint:** If you open the PDF document and then click on **View** and **Show/Hide** and **Navigation Panes** and **Bookmarks**, you can then click on any part you want to view, in the Bookmarks, and it will take you right there.
 - b. **Note:** The terms and conditions that apply to a Standing Offer and/or a resulting Call-up against a Standing Offer are those included in **Part 7 – Standing Offer and Resulting Contract Clauses** and in **all Annexes** of this RFSO document.
2. Update 1.2.2 in Part 1 to indicate that the Canadian Free Trade Agreement has replaced the Agreement on Internal Trade.
3. Amend **2.3 Former Public Servant** in Part 2 to move the definitions and certifications to **Attachment 3 to Part 3 – Certifications and Additional Information** and to require completion and submission of that attachment.
4. Amend **3.1 Offer Preparation Instructions** and **Section III** in Part 3 to add that **Additional Information** is also required with the **Certifications** that are to be submitted.
5. Delete **3.1.1 Electronic Payment of Invoices – Offer** from Part 3 and delete **Annex “C” Electronic Payment Instruments**, and move that information to **Attachment 3 to Part 3 – Certifications and Additional Information**.
6. Publish a separate document for **Attachment 1 to Part 3 – Request for Standing Offer Application** that is in a fillable PDF format.
7. Publish a separate document for **Attachment 3 to Part 3 – Certifications and Additional Information** that is in a fillable PDF format.
8. Amend Part 5 to move most of the information to **Attachment 3 to Part 3 – Certifications and Additional Information** and to require completion and submission of that attachment.
9. Delete **Attachment 1 to Part 5 – Certification Requirements for the Set-Aside for Aboriginal Business** from Part 5 and delete **Attachment 2 to Part 5 – Owner/Employee Certification – Set-Aside for Aboriginal Business** from Part 5, and move that information to **Attachment 3 to Part 3 – Certifications and Additional Information**.
10. Amend annex number on all references to insurance requirements to **Annex “C” Insurance Requirements**.
11. Amend annex number on all references to utilization report to **Annex “D” Utilization Report**.
12. Amend title and content of **7A.3.2 Periodic Usage Reports – Standing Offer** in Part 7A to require reporting of purchases acquired and paid for by Canada acquisition cards.
13. Amend **7A.8.2 Detailed Carrier-selection Process** in Part 7A to indicate that the standard procedures apply to the Competitive Call-up Process and to add a Directed Method for Requirements of \$25,000.00 or below.

14. Amend **7A.9 Call-up Instrument** in Part 7A to allow:
 - a. that, for low-dollar-value requirements, the Work be authorized or confirmed by using Canada acquisition cards;
 - b. the use of an electronic call-up document or a form that is equivalent to the form PWGSC-TPSGC 942 Call-up Against a Standing Offer.
15. Amend **7A.10 Limitation of Call-ups** in Part 7A to allow for use of the Canada acquisition card, subject to the departmental financial delegation limits for the card.
16. Amend **7A.12 Priority of Documents** in Part 7A to remove reference to deleted Annex "C" Electronic Payment Instruments.
17. Publish a separate document for **Annex "D" Utilization Report** that is in a fillable MS Excel format.
