DELIVERABLES / SCOPE OF WORK

Work under this Contract includes but is not limited to the provision of all labour, materials, and equipment required to:

1. Mobilize to site with a work barge of appropriate size and certification;
2. Fabricate and supply one steel jig for use in pier;
3. Install new drilled steel pier;
4. Install one new CCG supplied ATON (Aid to Navigation) tower on this pier;
5. Salvage existing ATON tower complete with all appurtenances;
6. Demolish and dispose of existing abandoned pier;
7. Return the salvaged existing ATON tower to Coast Guard base located in Parry Sound;
8. Demobilize.

The following work will be undertaken by others and is excluded:

1. Supply one ATON tower;
2. Supply and install lantern, battery and solar panel onto new ATON tower.

Expected Start and Completion Dates

The services of the Contractor will be commencing on award of the contract. The expected completion date of this project is **October 31, 2017**.

MANDATORY REQUIREMENTS:

- The minimum acceptable amount of Public Liability and Property Damage Insurance is \$2,000,000.00 per occurrence. All tenders **must** be accompanied by confirmation from the tenderer's insurance company that the required insurance will be available upon contract award;
- The tenderer must provide tender security, at the tenderer's own cost, in accordance with the document entitled "Tender Security Requirements" as Bid Security is required for bids over \$100,000. Under these circumstances, the Tender and **original signed Bid Bond** must be delivered to the Closing Location prior to the closing date.

Note: All tender securities (Bid Bond) will be returned except that of the successful tenderer (Bidder), which will be retained until the successful tenderer (Contractor) has completed the said contract.
