Q10. Cost Item B is defined as, "Transportation / delivery costs for each container to be extra to the monthly rates" and Cost Item C is described as, "Pickup and return costs for each container to the Contractor". Would you be able to explain the difference between these two costs?

A10. The unit price for Section B would represent the all the costs associated with transporting/delivering the container to the specified site. The unit price for Section C would represent all the costs with picking up and returning the container to the contractor's premises. Costs are additional to the price for the monthly rental charge.
