### Question 1

To that end, we formally submit a request to Public Safety Canada for a second on-site inspection with the following scope:

- all three buildings as outlined in Section 4 of Annex A (the Statement of Work)
- the location of each television currently receiving services, and any locations which Public Safety Canada reasonably expects could receive service given current use of the buildings
- wiring closets and infrastructure spaces currently used as part of the routing of the existing cable plant
- rooms where equipment to provide the current solution is located, and any rooms where Public Safety Canada expects to keep equipment associated with the new solution
- the roof of each building, and infrastructure elements which could support routing of cabling from the roof to other parts of the building

### Answer 1

Public Safety is pleased to offer an OPTIONAL SITE VISIT scheduled for Friday August 11<sup>th</sup>, 2017 at 9:00am (EST). Each building will be visited. Building representatives have request safety footwear be provided.

Note: Public Safety Canada will not be able to guarantee visits to the location of EACH television currently receiving services.

Note2: Secure locations that require TS clearance will not be included.

It is recommended that the Bidder or a representative of the Bidder visit the work site. Arrangements have been made for the site visit to be held at **269 Laurier, Ave. West** (including visits to 257 Slater and 340 Laurier) on **Friday August 11<sup>th</sup>, 2017**. The site visit will begin at **9:00 AM EST** in the lobby of 269 Laurier Ave. West (Laurier side).

Bidders are requested to communicate with the Contracting Authority no later than 15:00hrs on August 10<sup>th</sup>, 2017 to confirm attendance and provide the name(s) of the person(s) who will attend. Bidders may be requested to sign an attendance sheet.

Bidders who do not attend or do not send a representative will not be given an alternative appointment but they will not be precluded from submitting a bid. Any clarifications or changes to the bid solicitation resulting from the site visit will be included as an amendment to the bid solicitation.
