AMENDMENT #001

The intent of this amendment is to answer questions from potential bidders and revise some areas of the Request for Proposal document.

Q1. In reading the above-referenced Request for Proposal, we would like some information clarified.

On page 11/39 of the invitation to bid document, it is indicated that an operating licence for Ontario must be provided.

Groupe Intercar is interested in providing you with and is licenced to provide you with transportation and rental services without a driver for your needs from Quebec City, Saguenay - Lac-Saint-Jean and the North Shore.

Is it possible for us to make a bid for only these needs? Or do you maintain the requirement of an operating licence for Ontario? We do not have this licence.

A1. As the majority of pick ups will be in Ontario, the Offeror must hold a valid Public Vehicle Operating License in the Offeror's own name, and should provide a copy of it with their offer to demonstrate that they are licensed to provide bus charter service in the Province of Ontario as required in Annex "A", for the Area(s) of Service specifically identified by the Offeror in Annex "C".

The error message in Acrobat Reader reads as follows:

A2. Please disregard that attachment. There had been a problem with buyandsell recognizing the fillable attachments that were uploaded. It required our tech support to create the PDF document you referenced in order for the attachment process to work.

Q3. Page 27 section 7.1 (ii) notes in part, the following:

A charge is to be paid if the request for service has not been cancelled at least 12 hours in advance of the stated pick up time in the call-up.

However the proposed new Ontario Labour rules that are to take effect January 1st 2018 require the following:

"If a shift is cancelled within 48 hours of its start, employees must be paid three hours at their regular rate of pay."

Will the PWGSC consider changing the Cancellation Policy to reflect the new Ontario law so as to fairly compensate scheduled drivers?

A3. The cancellation timeframe will not be changed. Any proposed revisions to the Employment Standards Act have not been passed by the Provincial Government of Ontario and it is the bidder's responsibility to account for any financial risk that may arise.
