SOLICITATION AMENDMENT No. 001

This solicitation amendment No. 001 is raised to:

- 1) publish questions and answers that have been received in relation to this solicitation;
- 2) amend the solicitation.

- 1) The following Questions and Answers have been provided:

QUESTION 1:

Re: Pg 21/35; 5.2 Category B - Why is there no Preparation time allotted for Preparation time for participation in the OSCE and History practice sessions? Based on the amount of preparation entailed to participate in OSCE and student practice sessions (basically history taking practice) there should be a time allotment for preparation.

ANSWER 1:

Normally this function is built into the schedule itself, during practice/evaluation sessions personnel have the opportunity to develop a standardized patient amongst the PA/Physician team prior to commencement of the OSCE here at CFHSTC, the specific OSCE's are already chosen whereby time is afforded for this preparation.

QUESTION 2:

Pg 15/35; 6.4 "There is no security requirement applicable to the contract." Why for this contract there is no security requirement when there has been in the past?

ANSWER 2:

There is no security requirement, when there has been in the past, because the contract service provider does not need to access the Defence Wide Area Network (DWAN) to access information related to the PA Program or deliver lectures to the students. The contract service provider can access pertinent information (ie Training Plan, Master Lesson Plans, deliver lectures, etc.) utilizing a USB stick and or a stand-alone computer.

- 2) At Part 6, Resulting Contract Clauses, Article 6.5 (b) Option to Extend the Contract.

Delete: Article 6.5 (b), in its entirety, and

Insert: The Contractor grants to Canada the irrevocable option to extend the term of the Contract by up to four (4) additional one (1) year period(s) under the same conditions. The Contractor agrees that, during the extended period of the Contract, it will be paid in accordance with the applicable provisions as set out in the Basis of Payment.

Canada may exercise this option at any time by sending a written notice to the Contractor at least thirty calendar days before the expiry date of the Contract. The option may only be exercised by the Contracting Authority, and will be evidenced for administrative purposes only, through a contract amendment.
