Amendment 005 includes two sections: Section 1, to answer bidder questions and Section 2, to make changes to the solicitation in Section 2.

Section 1 - Bidder Questions

Q1: I would like to know how DND would like offerors to address or indicate the unit of measure difference? For example, the Annex E – Appendix 1 requires a product in a 4L container and our offering is in a 5L. Thus there will be less annual consumption required, and the unit price will not be accurate.

R1: Offerors are required to request an alternate size which may or may not be approved by DND.

Q2: Item 79 Instant Hand Sanitizer 1000ml – How many units by case?

R2: The item description has been changed to 1200ml. There are two (2) 1200ml per case and the item code is 1913-02-Can00.

Q3: To be able to provide the equivalent product that would fit the dispensers as requested in the description, Can DND provide the manufacturer name and part number currently being used for the following products?

Item 19 Hand Soap - An Economical Fragrance free foaming soap that is not drying and can be used in most dispensers

Item 28 Foam Soap - Hand soap without alcohol .Green Seal Certified .4m1 per pump

Item 79 Instant Hand Sanitizer 1000m1 - Use in most dispensers

R3: Item 19 - Avmor EP71 Foam soap 4L;

Item 28 - Jansan Pink Pearl Liquid Hand Soap;

Item 79 - 2x 1200ML Purell 1913-02-CAN00

Q4: For the garbage bags product items 1,2,3,4 & 5 would DND accept these if available on a roll? Can DND you provide the current manufacturer's name and number?

Q4: Rolls are acceptable as long as the pack sizes are the same. Jansan is the current name brand.

Q5: For the garbage bags items 1, 2 & 3 can you clarify that these are biodegradable bags you are looking for?

Q5: Degradable additive must be in all bags as per the description in Annex E – Appendix 1.

Q6: As per Amendment 003, DND specifies that if offerors propose a product of the same size as in Annex A, the items will fit in the dispensers. For Item 8, we can offer 1000 feet white universal paper rolls as requested in the Request for Standing Offer. Can DND confirm that as long as offerors propose 1000 feet white, we should be compliant and will fit the dispensers mentioned in the line 8. Wausau paper dispenser 86800 is a Proprietary model.

If DND cannot confirm that Universal paper rolls of requested size can fit in the dispensers for Line 8, then offerors need to change all the dispensers which is extra cost to the bidders. It will not be a fair evaluation as not all of the bidders will carry a particular proprietary refill. So please allow us to quote proprietary paper rolls with no charge dispenser program or allow us to quote universal paper for Line 8 for a fair evaluation. Also please provide us with the max number of Wausau dispensers that may need to be switched if PWGSC prefers proprietary paper rolls with no charge dispensers.

R6: DND requires that the paper rolls 1000' fit the existing dispenser. It is up to offerors to determine whether their paper rolls can fit into the existing dispensers. Public Services and Procurement Canada encourages an open and fair procurement process therefore, if the Wausau is a proprietary model, we have permitted offerors to quote their own Roll Paper Towels White 1000' (Hand drying) products as long as the dispensers are installed with no additional cost. This question was also addressed in Amendment 002, Question 11.
