### **Questions and Answers**

**Q1:** Regarding Specification 01 35 43 Environmental Procedures, clause 1.6 Site Clearing and Plant Production; sub-clause 1.6.4 states "wrap in burlap, trees and shrubs adjacent to construction Work, storage areas and truck lanes, and encase with protective wood framework from grade level to height of 2 m minimum". Please clarify if this requirements [sic] applies to either both of the above-referenced projects.

**A1:** *At AEC 32 it is sufficient to erect a delineation barrier past which equipment should not travel in order to protect trees and shrubs adjacent to construction work, storage areas, and truck lanes.*

**Q2:** For line item 35 could the location approved storage area be provide [sic]? A site plan showing this would be helpful.

**A2:** *In regards to line item 35 of the Unit Price Table for AEC 32, please reference Specification 01 11 00 Summary of Work section 1.1.36 "Soil Relocation from Cell to Storage Area will be paid in accordance with unit rate price established for volume of soil from the LTF that is to be relocated to a storage area in or near the LTF (within 300 m)." The contractor can propose a storage area but the PSPC departmental representative and the Watson Lake Airport manager must approve the location.*

*The location of the land treatment facility (LTF) is indicated on Figure 1 in the Specification package and was also visited during the bidder's meeting on August 16, 2017.*

**All other terms and conditions remain unchanged.**
