Question 8 :

Can the RCMP provide some pictures of the location of the new tower (including existing access road, parking road and garage)?

Answer 8 :

A photo gallery and presentation showing the location of the current tower and proposed site for the new tower have been attached.

Question 9 :

Are drawings of the existing tower available? Are there other descriptions of the existing tower that are available such as inspection reports or structural analysis report or the alike?

Answer 9 :

Answer 11:

The RCMP has the authority to contract for services up to \$2M for open bidding competitive solicitations.

Question 12 :

In the table of contents (on page 16 of the RFP document), the word « surveys » is plural.

15.0 APPENDIX C – Geotechnical Surveys

The heading on page 54 is similar.

The pdf document on the Buy&Sell appendix contains only ONE geotechnical survey prepared by Jacques Whitford (File 1004979).

Is this the only document or other documents have to be provided by RCMP? Please clarify.



Answer 12:

The geotechnical report provided on <u>www.buyandsell.gc.ca</u> is the only geotechnical survey.

Question 13 :

Since we now know the completion date of the work, what would be the delay required by RCMP to issue a formal contract following the closing date of the solicitation? This delay becomes critical to evaluate the schedule of work and activities that can be done before the cold season.

Answer 13:

The amount of time required to issue a contract following an open solicitation is based on various factors including how many bids are received. As this is an urgent requirement and no security clearances are required prior to contract award, the RCMP is aiming for an estimated 7 day turn around between receipt of bids and contract award.
