Notice is hereby given that the time for reception of tenders previously due at 2:00 p.m. P.D.S.T. on 29 August 2017 is hereby extended to **2:00 p.m. P.D.S.T. on 30 August 2017.**

Questions and Answers

Q1: Regarding Specification 01 35 43 Environmental Procedures, clause 1.6 Site Clearing and Plant Production; sub-clause 1.6.4 states "wrap in burlap, trees and shrubs adjacent to construction Work, storage areas and truck lanes, and encase with protective wood framework from grade level to height of 2 m minimum". Please clarify if this requirements [sic] applies to either both of the above-referenced projects.

A1: *This clause applies at AEC 22 as this is an area adjacent to an airport and the area is used by the public. Protection of trees adjacent to construction activities is required per the referenced section; however the successful bidder can propose an alternative means to protect the vegetation if it offers the same level of protection and is pre-approved by the PSPC representative.*

Q2: Could more information be provided on the location and type of utilities located within the excavations?

A2: *The location and type of utilities must be determined by the bidder.*

Q3: I was wondering if the curtain liner shown in Drawing 8: AEC22 – Typical Backfill Cross Section is required to be one continuous piece. Would we require welding onsite to "close the loop"?

A3: *The curtain liner shown in Drawing 8: AEC22 – Typical Backfill Cross Section is placed in panels to extend from approximately 1m below grade to the toe of the slope. The panels must overlap a minimum of 0.5 m along the edge length. Welding of the panel seams is not required.*

Q4: Could further details regarding the proximity of the excavations to infrastructure in AEC 22D be provided? For example the train monument (See attached photo).

A4: *The extents of the proposed remedial excavation areas for AEC 22D are shown on Figure 6 of the Specifications.*

All other terms and conditions remain unchanged.
