Amendment 01

This amendment is being raised to provide some background and respond to questions asked at the optional site visit on August 9, 2017.

- It is like for like with the replacement of this fence; please stay on the line as much as possible and if you have to move the fence, always move it into the park. If you have to make a deviation to the fence that you think is necessary, contact the Project Authority to confirm that the deviation is necessary and to decide where the deviation should go.
- This contract is through some fairly easy fencing land. There will be a lot of rolling hills and flat spaces. There will only be a couple of steep spots in this contract.
- Against Mastad's, there is a ½ mile section of new posts; these just need anchors and braces. Whatever new posts are already there, please leave them for Mastad's to replace the ones that they have installed.
- A lot of the fence in this section is down on the ground and basically non-existent in some spots. The wire and the posts in this contract will be old, with the exception of the few new posts that have been installed to keep some of the fence up and usable.
- There is only one bad hill in this contract and it is on the East/West section against Popescul's. If you want to go around this hill, that would be fine, but deviate into the park if you choose to. There shouldn't be much of a problem to fence over top of this hill, but it is the contractor's choice. If you choose to go over this hill you can use steel posts if you choose, the steel posts have to be 7 feet with the drilled out holes, do not use the ones with the ribs.
- There will be some swampy sections in this contract. However, being as it has been so dry this year, they shouldn't be a problem unless we get a lot of moisture.
- Stainless steel water cannons must be carried with you at all times on your equipment. There should also be some kind of firefighting unit with you at all times.
- Parks will supply all the bin anchors for this contract.
- Make sure all posts and rails are treated with green treat.
- There might be cattle at large in these areas when you are fencing, so be prepared to deal with that and fence accordingly.
- Have a spill kit with you at all times. Also report any spills to the Project Authority so they can be documented.
- Cell service should be good at the tops of hills, but will be spotty to non-existent when you are in low areas.
- Camping will be allowed at approved staging areas on Parks' property.
- The contractor is responsible to do line locates before pounding posts or digging in bin anchors.
- 3 wire fence doesn't require metal stays -- just use doubled over wire to hold the wires to the anchor.
- Tracked machines are permitted but the tracks cannot be steel; they must be rubber.
- All corners are to be single braced. For gates, the number of rails must match the number of wires (ex: 3 wires would mean 3 rails). Gates must also be a minimum of 16 feet wide with 7 foot spacing on the braces.
- All brush and trees will have to be cleared out of the fence line, but only clear a path wide enough to get equipment through and work in.
- The project end date is December 31, 2017, depending on weather. Pounding posts after there is frost should not be a problem.

Site Visit Questions

Q: Are there any requirement for the old post holes?

A: They are to be spaded shut.

Q: How do you fasten the braces?

A: Screws or spikes - contractor preference. Rails on gates must be #9 wired as well.

Q: What are the snakes like here?

A: There is not much for snakes around this area.

Q: Do you come out for equipment and safety checks?

A: The Project Authority will be out once a week, but the contractor is responsible for their own safety protocols and PPE.
