Question 13: Regarding the Project Manager / Principle Investigator Experience,

It seems that the PM and PI duties might be best addressed for the client through 2 resources, one in the role of expert PM reporting to the PI and then the PI himself.

Would it be deleterious to our bid in proposing this; we see added value in this approach.

Answer 13: It would not be deleterious to your bid.

It is up to the Bidder to determine the best allocation of resources to represent both their research plan and the requirement reflected in Annex A, Statement of Work. Canada has only identified the *minimum* requirements as they relate to resources, both human and other. As such, you are free to address the resource requirements as you see fit.

Question 14: If I have already submitted a bid, can I submit a new bid with changes before the closing date of the RFP?

Answer 14: Absolutely. If you wish to submit a new proposal before the closing date of the solicitation, simply indicate “This bid cancels and supersedes the previous bid submission dated _____ (*insert date*) by [*name of organization*]” in the submission.
