- Amend the Mandatory Evaluation Criteria at 4.1.1.1;
- Amend the Annex "A" Requirement at Subsection 2.2 "Technical requirements, and;
- Facilitate the second round of questions and answers.

### <u>1- At PART 4 - EVALUATION PROCEDURES AND BASIS OF SELECTION, article 4.1.1.1</u> <u>"Mandatory Technical Criteria", MTC1:</u>

Delete:

- Chairs must be Walnut in colour (the colour requested is that of a faded medium to dark brown, and must not contain any red tint); and,
- The backing must be of ladder back style.

#### Insert:

- Chairs (including frame) must be Walnut brown in colour (the colour requested is that of a faded medium to dark brown, and must not contain any red tint); and,
- The backing must be of ladder back style (horizontal support).

### 2- At PART 4 - EVALUATION PROCEDURES AND BASIS OF SELECTION, article 4.1.1.1 "Mandatory Technical Criteria", MTC2:

#### Delete:

 Table tops must be solid wood and be Walnut in colour (the colour requested is that of a faded medium to dark brown, <u>and must not contain any red tint</u>); table colour to match colour of chair seat.

6.4.2; regarding the delivery date of October 6th. Is it possible to have a later delivery date? Any resulting contract wouldn't be awarded until September, leaving little time for manufacturing items, especially insuring that the colour of the wood and metal match your criteria.

## **A1**

The delivery date will be extended to 30 November 2017 (RFP Amendment 02).

### Q2

Annex A 2.2.1 b; Is it meant that the actual colour of the steel frame be a walnut colour or is this just a reference to the seat and seat back?

### A2

Chairs (including frame) must be Walnut brown in colour (the colour requested is that of a faded medium to dark brown, <u>and must not contain any red tint</u> **(RFP Amendment 03)**.

## Q3

Annex A 2.2.3 a; Is it imperative that the bases are a cast iron. We make everything from hardened steel which is a much stronger and longer lasting material.

### A3

Table bases must be made of Cast Iron or steel (RFP Amendment 03).

### Q4

Does the recent amendment, removing the Nafta requirement, then allow imported goods from all countries be valid products for the RFQ?

### A4

Amendment 01 to the RFP removes the reference to the Agreement on Internal Trade (AIT) at PART 1, article 1.4, and replaces it with the Canada Free Trade Agreement (CFTA). There has been no change with respect to the reference to NAFTA, as NAFTA applies to this purchase **(RFP Amendment 01)**.

### Q5

Regarding 2.2.2. b – Is it possible to use a 30mm thick laminated solid wood (i.e. Baltic Birch plywood) for the tabletops.

### A5

No, the table tops must be as specified at Annex "A" Requirement, subsection 2.2.2, and in MTC 2.

### Q6

We have a stackable lounge chair which has contoured solid wood back. Will this be acceptable?

### A6

No, chairs must be as specified at Annex "A" Requirement, subsection 2.2.1, and in MTC 1.

## Q7

In RFP # W8474-187469, MTC1 mentions a metal chair with wooden seat and the specified color is walnut. Can you confirm the color required for the metal?

## A7

Chairs (including frame) must be Walnut brown in colour (the colour requested is that of a faded medium to dark brown, <u>and must not contain any red tint</u> **(RFP Amendment 03)**.
