QUESTIONS:

The following questions were received from bidders. To ensure consistency and quality of information provided to Bidders, significant enquiries received and the replies to such enquiries will be provided simultaneously to all Bidders to whom the bid solicitation has been sent.

QUESTION 1:

With respect to Page 34, Clause 14.3 (location of Canada's data) and 14.16 (safeguarding of Protected B information) and based on the Government of Canada Cloud Adoption Strategy at <https://www.canada.ca/en/treasury-board-secretariat/services/information-technology/cloud-computing/government-canada-cloud-adoption-strategy.html> to ensure Canada's sovereign control over its data, all sensitive or protected data under government control will be stored on servers that reside in Canada.

- A. Can LAC confirm that the need to ensure Canada's sovereign control over its data is a mandatory requirement?
- B. Can LAC confirm that any compliant SaaS PaaS and IaaS solution would require a minimum of 2 data center locations in Canada to provide primary and redundant fail safe services?

RESPONSE 1:

- A. Yes, as stated in SOR "4.8.9 (M) The content and all associated metadata managed by the system must reside within Canada." and stated in the "[Cloud Security Control Profile Selection table](#)" from the Treasury Board Secretariat "[Right Cloud Strategy](#)", the PBMM security profile requires Canadian data residency.
- B. As stated in [ITSG-33 Annex 3A](#):

CP-7 ALTERNATE PROCESSING SITE

Control:

- A. The organization establishes an alternate processing site including necessary agreements to permit the transfer and resumption of [Assignment: organization-defined information system operations] for essential missions/business functions within [Assignment: organization-defined time period consistent with recovery time and recovery point objectives] when the primary processing capabilities are unavailable.
- B. The organization ensures that equipment and supplies required to transfer and resume operations are available at the alternate processing site or contracts are in place to support delivery to the site within the organization-defined time period for transfer/resumption.
- C. The organization ensures that the alternate processing site provides information security safeguards equivalent to that of the primary site.

Supplemental Guidance: Alternate processing sites are sites that are geographically distinct from primary processing sites. An alternate processing site provides processing capability in the event that the primary processing site is not available. Items covered by alternate processing site agreements include, for example, environmental conditions at alternate sites, access rules, physical and environmental protection requirements, and coordination for the transfer/assignment of personnel. Requirements are specifically allocated to alternate processing sites that reflect the requirements in contingency plans to maintain essential missions/business functions despite disruption, compromise, or failure in organizational information systems. Related controls: CP-2, CP-6, CP-8, CP-9, CP-10, MA-6.
