Questions and Answers

Q1: Please provide updated drawings showing the tree line at each excavation location so that it is clearer how much clearing and grubbing is required.

A1: *Information regarding the amount of vegetation to be cleared and grubbed for each excavation location was available during the Site visit on August 16, 2017 and should have been collected at that time.*

Q2: Could floor structure and wall foundation as built/details be provided for the terminal building were the proposed excavation limit extends beneath in AEC B?

A2: *The foundation and structure details are not available and the excavation is planned to extend to the closest safe approach to the building as determined in the field by the successful bidders appropriately qualified professional. The Departmental Representative may retain an appropriately qualified professional to determine the closest approach limits if there is a concern with the limits proposed by successful bidder.*

Q3: Could clearing and grubbing wastes be left onsite if >6" wood and above is neatly stacked and chips are spread out in the forested areas?

A3: *Chipped material can be intermixed in the top soil and used onsite for soil reclamation but large debris over 15cm in length must be removed.*

All other terms and conditions remain unchanged.
