Questions and Answers

Q1. Stamps Narrows – Existing piles remain correct?

A1. Correct

Q2. Pilings on LL160/161/168 – Are they Grade 2 or Grade 3? Can we use straight seem pipe or even spiral pipe?

A2. Grade 3. Yes

Q3. It states “piles driven to penetration resistance criteria given in the geotechnical report. Where is this report?

A3. To be provided following contract award

Q4. Is it fair to assume we do not have to drill any piles?

A4. Yes it is assumed that no drilling is required

Q5. Is the owner supplied material available to the contractor immediately after the contract is awarded? If we were successful would we be able to start right away?

A5. Ideally we will need approx. 4 weeks to have the material available. This will be reviewed following submission of the Contractors Schedule and can be expedited if required. Work cannot start until we receive contract security, insurance, and WCB clearance.
